Minutes of the meeting of the **Planning Committee** of the Chipperfield Parish Council held on Monday 20th January 2014 held in the Small Hall, The Common, Chipperfield at 7.15 pm

Prior to the meeting Mr Morrell spoke on behalf of the Chipperfield Project Group. Planning Permission for the additional burial ground had been granted on 5th September with the condition that the treatment of the boundary was notified to DBC before work commences. The proposal from the group that the boundary will consist of post and rail fencing with beech or hornbeam hedging and a quotation of £4000 including the gates had been received, this was based on the volunteers doing the work. To provide a flint wall along the roadside to match the existing, which is Chipperfield Parish Councils preferred boundary, would cost in the region of £12,000 and this cost was prohibitive to the group. It was understood that County Councillor Roberts had implied that grants for this were available and the Clerk mentioned the Awards for All scheme that gave out grants to community groups and would send the details out to them by email. It was agreed that this matter would be discussed by the Council in its F & GP working group and at future Parish Council Meetings.
